Narrative text

At approximately 1525 my self, ofc. Moniz-Shawk #218, and ofc.Thibodeau #216 were informed by Alisha Alexander from athletics that a media person named "Bob" was sitting in people's seats again.

Prior to this contact we met with Alisha Alexander. She informed us about Bob going inside the ACC, where he is not allowed, going into the umpire area, and that he was sitting in people's seats. Ms. Alexander stated she did not want him removed right now but if anything else happened to remove him.

When Alisha talked with 216 and myself a second time, she explained that Bob had been asked to leave the seat he was at by both viewers of the game and the security (Best security)near the stands but did not move. After informing Director Guenthner #202 about this, we were instructed to ask Mrs. Alexander if she wanted us to revoke his media status and escort him off the premises in which she replied "yes". After informing Director Guenthner of Ms.Alexander's answer he ordered us to make contact and to escort him to the ticket booth. We found Bob sitting in a reserved seat along first base. I made contact with him and informed him to come to the ticket booth so we can talk and then proceeded to escort him to the ticket booth where we meet with Director Guenthner. After Director Guenthner took Bob's media pass,and informed him that he was being asked to leave the campus due to sitting in people's reserved seats and generally causing a ruckus. Director Guenthner had myself and 216 follow Bob through campus until he reached the 4 th ST parking lots where we connected with Officer Lansing #266 where he took over watching Bob go to his car.
